- **Need to Achieve Carbon Neutral Status:** Although solar panels are installed the college should prioritize sustainable practices and initiatives to achieve a carbon-neutral status. - **Lack of Research Projects and Government Funding:** The college faces challenges in obtaining research projects and securing government funding. The design and implementation of curricula is done as per the requirements of the community through the inclusion of pharmaceutical subjects as governed by University and statutory authorities. By hosting a blend of guest lecturers, the institute helps students improve their whole personalities by teaching them how to communicate effectively and how to handle interviews. Students, with the help of the institute's computers and internet access can evolve in innovations, in research techniques and provide recommendations for excelling in various fields of Pharmacy. At the collegiate level, an animal ethical committee (IAEC) has been established in 2007, which aids in screening of wide range of medicinal plants and synthetic agents legally. To help students build employability skills, the institute's training and placement division hosts talks by business leaders, experts from various Pharmaceutical industries and Hospitals. The teaching methods and techniques may vary, once students' grasping capacity is judged through initial examinations and viva-voce. ICT enabled teaching methods help the students in better understanding of subjects. The teaching staff at college is blend of young-enthusiastic and

experienced Ph.D. holders, from different universities. They plan their teaching sessions in advance with a focus on course outcomes and delivery are supported by tools like LCD, e-journals and books etc.,. Teachers are motivated to update their knowledge by attending conferences, workshops and Seminars. They strive to improve their performance based on students' feedback. The achievement of learning goals is supported through ICT enabled, demonstrative, participative teaching and guest lectures. Students' performance is evaluated based on in-semester and end-semester examinations. For their accomplishments in a variety of sports and academic activities, students receive a variety of rewards and incentives. The examination contains questions that assess knowledge and understanding as well as analytical and problem-solving skills through application-focused questions. The evaluation process is open and the examination department handles any student grievances that may arise. The department's activities include the student performance and learning outcomes as an essential aspect. He received Indian Iconic Personality Award in year 2019. Dr. E. Ventakeswarlu and Dr. B.S.Sharvana bhava received best preceptor award from IPC-PVPI, Ministry of health and welfare, government of India. Dr. B.S.Sharvana bhava received best poster award by Indian Association of Colleges of Pharmacy. The institution was allotted a National Service Scheme Unit and "Vaaganubandh" is associated with it.

### **Infrastructure and Learning Resources**

Vaagdevi College of Pharmacy sprawls across more than 8164 sq. mt of buildup area, nestled in over 2.5 acres of land, in center of the city of Hanamkonda.

The institution has taken significant precautions to ensure round-the-clock safety and security on campus and

has appropriate facilities like CCTV camera surveillance to ensure the safety and security. To meet the evolving needs of the modern academic era and to foster a successful teaching-learning process, college have always placed their best on the development and improvement of their infrastructures to meet the needs of stakeholders. Digitally equipped Lecture halls & Seminar rooms for students are available in the campus and also utilizing funds to enhance teaching process in a more effective way.

Instruments like UV Spectrophotometers, HPLC, FTIR, Dissolution and Disintegration apparatus, Bulk Density apparatus, Franz Diffusion Cell, Iontophoretic cells, Tablet Punching Machine, Lozenges Moulds, FlamePhotometer, BOD Incubator, Inoculation Chamber, Fuming Chamber, Plethysmometer, Autoclaves, Auto analyzer, Spirometer, Crude drugs, Biological and human specimens, the museum and many more equipments are present which help in enhancing the practical knowledge of students. Animal house is managed in accordance with CPCSEA norms. The institution has a subscription to the Micromedex and Ex-pharma softwares following PCI and CPCSEA guidelines. The teaching programmes are supported by outstanding infrastructure facilities, well-equipped and sophisticated laboratories. The campus also houses facilities like Generator Room, Auditorium, Gym, playgrounds, Volley Ball, Table Tennis, Badminton, Girls Waiting Halls, Boys Common Rooms, Yoga room, Sick room, Medical room, Hostels, Canteen, Medicinal Garden etc.,.

The institute has a digitally equipped Central Library with a great seating capacity. They are conscious of Vaagdevi's fundamental mission to empower future generations, and as an outcome, they practice a unique skill of teaching and employing a student-centered, transformative approach.</p>
6. Distance education/online education:	<p>Vaagdevi College of Pharmacy is unable to provide independent distance learning/ online learning/ few courses because of its affiliation with Kakatiya University and strictly obeying the regulations of the university. However, throughout the pandemic, academic staff members quickly transitioned from classroom to online instructions and successfully employed platforms including GOOGLE MEET, GOOGLE CLASSROOM, MICROSOFT TEAMS, CISCO WEBEX, GOOGLE GARAGE, PHYGITAL, ZOOM and YOUTUBE for blended learning. As a consequence of the lessons discovered during the Covid-19 shutdown period, access to online resources will no longer be restricted for professors and students. Due to the fact that MOOCs support the blended learning approach to education, professors are encouraging the students to enrol and provide them. Education is now more accessible because of this strategy, especially for underprivileged students.</p>

To ensure the smooth functioning of the ELCs, Student coordinators/Campus ambassadors/Members are appointed from students and Nodal Officers from the faculty are appointed. Any student can voluntarily enroll as a member of the ELC at the beginning of the academic year. ELC also has an Executive committee by an elected body from among the ELC member students. This committee only has students who are already enrolled as voters and the committee will not include students who are politically active. These individuals play a pivotal role in organizing activities, coordinating events, and motivating students to actively participate in electoral literacy initiatives. The ELCs are designed to encourage students from diverse backgrounds to be part of the club and contribute their unique perspectives.
3. What innovative programmes and initiatives undertaken by the ELCs? These may include voluntary contribution by the students in electoral processes-participation in voter registration of students and communities where they come from, assisting district election administration in conduct of poll, voter awareness campaigns, promotion of ethical voting, enhancing participation of the under privileged sections of society especially transgender, commercial sex workers, disabled persons, senior citizens, etc.	The ELCs have undertaken various innovative programs to promote electoral literacy. Student Members & Teachers actively contribute to electoral processes by engaging in voter registration drives for themselves and the communities they belong to. Moreover, the ELCs organize voter awareness campaigns, promote ethical voting practices, and work towards enhancing the participation of underprivileged sections of society, including transgender individuals, disabled persons, senior citizens, and marginalized communities. Some initiatives taken by ELC include Ballot Bistro, which comprises discussion and brainstorming sessions in the college canteen. This activity is moderated by ELC members and any student can participate in the activity. The session is conducted with a mixture of English and local languages. Each Ballot Bistro has its theme which is fixed by ELC members and the discussions follow on the theme where students are free to voice their opinions. Special Registration Drive- This session is conducted to register students of 18 years or above as electors. The ELC members are in charge of leading the session on how to register by filling out Form 6 and discussing the various papers needed. ELC members are also responsible for educating students from other states and cities on how to get registered online through the <a href="http://www.nvsp.in">www.nvsp.in</a> portal. National Voters' Day Celebration- On Jan 25th of every year ELC members hold a special

##### **Response:**

Vaagdevi College of Pharmacy ensures effective curriculum planning and delivery through a well-planned and documented process including Academic calendar and conduct of continuous internal Assessment.

The institute has dedicated vision, mission and objectives and are efficiently interfaced within the stakeholders. Being affiliated to Kakatiya University, the institute implements the curriculum and imparts quality education as described by the University.

College has constituted **Academic Monitoring Committee** which constitutes of the principal, academic coordinator, academic incharge, heads of all departments and respective class incharges. All the academic activities are well planned and monitored by academic monitoring committee which reviews the curriculum and identifies the activities that bridge the curriculum gaps. Faculties are encouraged to impart the curriculum through innovative teaching methods such as presentations, assignments, discussions, workshops, seminars and industrial visits besides the regular traditional chalk and talk methods. The academic performance of students is continuously monitored by conducting viva voce regularly during the semester. Academic monitoring committee prepares an Institutional Calendar with reference to the University calendar issued by the Kakatiya University annually. With reference to the Institutional Calendar, HOD'S of various departments to prepare respective departmental Calendars, which summarizes the plan of various teaching-learning, co-curricular and extracurricular activities.

Feedback from industry and alumni is given due importance in defining graduate attributes and design of course outcomes. In case of any deviation, remedial actions and improvement strategies are adopted. Feedback from faculty and students at the end of every semester is analyzed for further improvement. Continuous internal Assessment is followed as per Pharmacy Council of India (PCI) regulations. Institution aims to achieve academic excellence and professional competency by the effective planning and implementation of the curriculum as per the guidelines of PCI & KU.

**For conduct of continuous internal Assessment**, Examination department provides the time table for Internal Sessional examinations and communicates the University exam schedule to the students and faculty immediately when it is displayed and updated on the university website. The library is well equipped with books, journals and periodicals as prescribed by the syllabus as well as additional

reference materials on the subject. Besides this the departmental library is used for sourcing references for conduct of practical. Guest lectures by eminent academicians, scientists and industry professionals are a value addition to the curriculum delivery process. Faculty also participates in workshops conducted for orientation to new subjects to ensure effective curriculum delivery. The institute ensures effective curriculum delivery through a certain organized, crisp, succinct, well-timed manner creating a scientifically documented pool well suited for both course instructor and students. In addition, the institute has been conducting events like World diabetic day, International Pharmacovigilance week, Free eye camp by NSS, Awareness rally on HIV/AIDs, Rally on “Don’t lend pharmacy registered certificate”, Awareness rally on the occasion of world glaucoma week, etc.

**Gender Issues:** Gender equality is the goal, while gender neutrality and gender equity are the practices and ways thinking that help in achieving the goal. Courses in UG and PG programmes like Human Anatomy & Physiology, Pathophysiology, Community Pharmacy, Pharmacotherapeutics-I, II and III Clinical Pharmacy, Hospital Pharmacy address various gender issues. A part institution represent high priority in implementation by maintaining Women Empowerment cell, events like International Women’s Day, World cancer day(Breast cancer awareness Rally), work shop on making jewellery, food fest by women, Discussion on how to tackle issues, cyber security and social media. Awareness Program on human rights, Navigating social media in responsible manner, health and hygiene, Beti bachao and beti padao etc.

**Human Values:** Honesty, fairness, respect, responsibility, caring and citizenship are the core of any

Student-centered learning allows for more flexibility of working class individuals to engage academically by studying remotely as individuals or in small groups. technique individualized learning with a skill-set approach aided by blended and remote learning methods and extended learning options. The student exhibits an increased sense of autonomy and shares the charge of their learning with their teachers. Technology has been an added advantage as teachers use technology to communicate instruction, model

learning, and engage students in deep learning. At the same time, the students use technology to access information, cooperate and communicate with their peers, and establish their learning path.

The student-centered learning methods and learning approaches are different from the method and models implemented in traditional teacher-centered learning. Adopting a student-centered approach with emphasis on students having full responsibility and accountability for their learning is challenging for teachers. It requires teachers to be facilitators and assessors in their teaching approach. SCL requires teachers to be responsive and evaluative as learners are active and accountable for their learning process. Identified key areas in instruction centered approach between teacher and student engagement: 1) teachers role and responsibility 2) learning outcome 3) assessment of result and performance 4) material environment 5) Power relationship between teacher and learner.

With the traditional implementation of Teacher-Centered Learning (TCL) in the curriculum and the shift to student-centered learning, some teachers fear that student-centered learning will worsen educational standards.

The learning experience can be tailored to learners' capabilities. There are various SCL techniques, ranging from easy implementation to higher complexity.

Methods of the student-centered learning approach include:

Problem-based learning: this approach requires students to solve shorter problems in a short time.

Project-based learning: this approach requires students to solve a complex real-world problem in an extensive period.

Inquiry-based learning: this approach requires students to solve a scenario leading to a shift from basic knowledge to a deeper understanding of critical thinking and evidence-based reasoning

Co-operative learning: this approach requires students to work in small groups to discover new concepts together. These methods can be also be carried out in groups, promoting co-operative learning

### **Principles of Student-Centered Learning**

This principle is based on Learners should develop their learning through communication, critical thinking, creativity, and collaboration.

Learners have the opportunity to decide on what to learn and things of real-life scenarios.

Teachers' assessment changes from summative assessment to formative assessment as learners are involved in the assessment.

### **Characteristics of Student-Centered Learning**

Increased students' autonomy towards learning.

Transformation from a passive learner to an active learner.

Reliance of deep learning and understanding

Enhanced responsibility and accountability on the part of the learner.

Developing a mutual respect between the learner-teacher relationships.

Adopting and recognizing students view in the teaching process.

Interdependent relationship between the learner and teacher.

#### Response:

The College is affiliated to Kakatiya University, Warangal, Telangana. The College follows the University's academic calendar, examination and assessment procedures for all programmes. The institute hosts an Orientation Programme for newly admitted students and their parents at the start of each academic year, during which the Principal explains the examination scheme, evaluation methods and passing requirements in detail to the new students and their parents. The academic calendar is published by KU before the beginning of each academic year and is available on the University Website. The start of the academic year and the last day of instructions for B. Pharmacy, M.Pharmacy, and Pharm. D students are listed in the academic calendar by KU. HOD's will distribute a copy of the academic calendar to the faculty of their respective departments. Academic calendars are posted in classrooms and on department notice boards. The institute has established an Examination Committee to look into all examination-related work at the institute level. The institute has appointed one of the approved faculty as Examinations In-charge in accordance with University directives. He communicates all exam-related matters to faculty and students via notices, which are displayed on the college notice board. The faculty must set the question paper for the sessional exams. The examination branch receives the question paper before the deadline. Assessment occurs in two levels i.e., Internal and External Assessments. In terms of assessment measures, the Institute adheres to the rules established by the Affiliating University and PCI. Internal and external marks for Pharm.D., are 30 and 70, respectively, for both theory and practical examinations. Three internal evaluations are directed, and the best two of the three will be considered. It is 30 and 70 for both theory and practical examinations for M.Pharm. (PG) and CBCS pattern for B.Pharm (UG). For B.Pharm, two internal examinations and one compensatory re-session test are held for each semester. Post results, students can apply for

recounting/revaluation to the affiliating university. Question papers and answer scripts are saved and documented for future reference. Students can request recounting/revaluation for university exams if they are dissatisfied with the results or have questions about their grades. They can apply to the affiliating university for recounting/revaluation.

#### **Response:**

Vaagdevi College of Pharmacy offers adequate infrastructural facilities for teaching and learning for students, which are maintained in accordance with higher education necessities in order to meet regulatory requirements AICTE, PCI and KU, Warangal, Telangana.

The institute has provided all the necessary equipment's and infrastructure for effective operations for B. Pharmacy, M.Pharmacy, PharmD, PharmD (PB).

The college's IT infrastructure, including Wi-Fi, is updated on a regular basis. Vaagdevi College of Pharmacy contains 204 computers for language laboratory and for the respective department usage . To enhance ICT-enabled teaching and learning, LAN and internet access are available.

Students are taught and encouraged to use technologically advanced instruments such as HPLC, UV-Visible Spectrophotometer, FTIR, chymogram, tablet punching machine, tablet coating machine, Probe sonicator, Freeze dryer, centrifuge, Micro plate reader, autoclave, hot air oven, laminar air flow, ampoule sealing machine and many more. To understand clinical aspects, students have access to a Drug Information Centre and a Patient Counselling Room.

**CLASS ROOMS:** All the PG&UG classrooms each with an adequate area in view of the illumination, acoustics and proper ventilation. The Basic facilities such as electricity, and comfortable seating arrangement are provided considering each classroom as one independent unit. The special classrooms are provided with an ICT facility of LCD projector, OHP and internet etc., to encourage the faculty to use innovative teaching methodologies to teach advanced topics.

**LABORATORIES:** The institution lays a very good foundation by establishing well-equipped modern laboratories 1 Computer Centre Laboratory for UG & PG subjects with adequate storage space. Each practical laboratory has displays in the form of charts, SOP'S, posters and safety instructions. All the practical laboratories are safeguarded with exhaust fans and a separate drain facility. The computer laboratories are provided with UPS to support the students during lab time and the office with backup facility.

**SEMINAR HALLS:** The institution has two seminar halls with a built-up area of 75\*22 ft and 32\*27 ft with 150 and 50 seating capacity arranged with LCD, Audiovisual facility and public address system. Two halls are used for student council meetings and ppt presentations of academics from each department.

**AUDITORIUM:** The institution has one AUDITORIUM of 59\*28 ft with 150 seating capacity. It is used to organize the FDPs, seminars, conferences etc. The Pharmacy department also maintains Museum. All departments have been provided with laptops, computers and LCD projectors with 10 MBPS internet facility.

Students are encouraged to participate in various social and cultural activities. The institution organises a variety of events to encourage students to participate in social activities such as dancing (group and solo), singing, skits, rangoli, poster making, painting, quizzes, and so on. The organisation offers sufficient Playground for outdoor activities such as Volleyball, Throw Ball, Cricket, Kabaddi, Kho-Kho etc., Indoor games such as Carrom, Chess, Badminton, and Table Tennis are also available in the ground premises.

Yoga and Meditation sessions are regularly organised on various Yogasana and Stress management in the college. The Gymnasium and yogacenter at the institute are also well-equipped.

This system serves as a digital tool that efficiently organizes and handles various tasks within the library and keeps records of books, journals, and other resources, making it easier for students and faculty to locate and use them. ILMS streamlines processes like borrowing and returning items, making the library operations more convenient. Essentially, ILMS acts as an assistant that enhances the library's functionality, ensuring an optimal experience for all users.

The library is modernized with an Online Public Access Catalogue (OPAC) allowing students and faculty to easily find books using criteria like title and author. Additionally, a dedicated reading room is provided. Accessible digitally, the library offers e-journals, e-books, and a substantial collection of over 14615 textbooks and 12 journals (both international and national). With around-the-clock internet availability, students and faculty benefit from a comprehensive and convenient learning environment. The library's online resources greatly enhance academic pursuits.

The NEW GEN LIB software is a valuable tool seamlessly integrated to empower students with convenient access to resources. It facilitates rapid data retrieval, simplifies stock checks, and streamlines processes for borrowing and returning books. Additionally, it offers valuable library support, enhancing the overall user experience. This software serves as a comprehensive solution, ensuring seamless navigation through the library's offerings and optimizing interactions with its resources.

The library provides students with 33 computer terminals, all equipped with the latest software and unrestricted internet access. It is thoughtfully furnished to enhance comfort and convenience, complete with printing and photocopying amenities for student use. The institution's commitment to enriching education is evident through its paid subscriptions to various electronic resources such as e-books, e-journals (DELNET), Micromedix and e-ShodSindhu. These valuable resources are readily accessible to students through the institution's digital library platform, facilitating seamless learning and research endeavors.

Furthermore, to ensure the smooth functioning of our institute's PG departments, dedicated departmental libraries have been established. Each student can borrow up to two books per card, with an option to renew for 15 days. Notably, the library houses authoritative compendia such as the British, American, and Indian Pharmacopoeias. Additionally, a well-maintained newspaper stand offers daily updates. To aid students, past semester question papers and university exam papers remain accessible, promoting

comprehensive academic preparation and success.

Newly enrolled students receive a comprehensive orientation from the library's faculty supervisor and dedicated staff. PG lab instruments interface with dedicated software via computer connections. An extensive LAN network interlinks labs, libraries, and offices. A specialized simulation lab enriches pharmacology studies, complemented by eight drug information systems accessible to PharmD students and Mahatma Gandhi Memorial Hospital staff. Individual departments are equipped with their own computer systems, reflecting a commitment to advanced technology-enhanced learning. Notably, the institution previously employed Clinical Learning-Pharmacology methodologies.

The Digital Library houses a suite of 33 computers, facilitating browsing of e-books, e-journals, and databases including DELNET, alongside valuable e-resources like e-Shodhsindhu, e-Shodhganga, and Z-Library. Automation is powered by the advanced NEW GEN LIB software. Internet connectivity remains seamless through the JIO Broadband service provider, delivering speeds of 50-100 MBPS. Robust password protection ensures data security, with non-academic sites appropriately blocked. Swift resolution of any technical concerns is ensured by the IT Help Desk and a dedicated network administrator. Enriching classroom experiences, LCD projectors are seamlessly integrated for instructional purposes.

For comprehensive campus security, the institute has strategically placed 64 closed-circuit cameras, their feed routed to a central monitoring station. Campus events find visibility through the institute's official website and social media platforms like Facebook and Instagram. The dedicated institutional website serves as a valuable academic resource hub, offering students easy access to essential information, diverse resources, and significant links, apart from showcasing the institution's academic milestones.

The Institution consists of advanced IT infrastructure facilities. An internet facility is seamlessly integrated into the network, further enhanced by Wi-Fi support services encompassing the institution's website, the College Administration and Management Software (CAMS), the library information system, as well as the presence of CCTVs, Biometric devices, and a Learning Management System (LMS). Moreover, the IT server centre stands as a stronghold with continuous 24/7 power backup and standby facilities, ensuring uninterrupted access to critical resources. The central computing center ensures internet connectivity on the provided systems. All departments are furnished with computers featuring internet access, while the central library hosts 33 systems with internet capabilities. Staff members across departments are facilitated with internet access to retrieve essential study materials from available e-resources. The Principal's Office, Administrative Office, Examination Section, Training and Placement Cell, and Senior Faculty member cabins are outfitted with computers and internet connectivity. The entire campus is seamlessly Wi-Fi enabled, ensuring consistent connectivity. Furthermore, uninterrupted power supply is guaranteed throughout the campus.

**1. Title of the Practice: Adverse Drug Reaction (ADR) reporting and Clinical Pharmacist activities are practically implemented in our college**

#### **2. Objectives:**

- Detecting, assessing, understanding and reporting of Adverse Drug Reactions (ADRs) to the AMC, KMC, under PvPI.
- Educate the students for direct contact with the patient health care system and endorsed to take critical decisions at prescribed medications in inpatient prescription.
- Train the students for clinical pharmacist activities like ward round participation, patient counselling, pharmacist's intervention, drug information, medication chart review, drug interaction, therapeutic drug monitoring, medication history interview (MHI), case reports and dispensing of medicines in dispensary.

#### **3. Context:**

The dream of our college is to generate competently skilled pharmacy professionals who will confidently

impact healthcare in society. The students are trained for pharmacist activities like ward round participation, patient counselling, pharmacist intervention, drug information, Adverse Drug Reactions (ADRs), medication chart review, drug interaction, Therapeutic Drug Monitoring, case reports and dispensing of medicines in dispensary.

#### 4. Practice:

According to the curriculum students are going to the hospital. It is a regular practice that the students are trained for pharmacist services which include ward round participation, patient counselling, case studies, case report, ADR reporting, drug interactions, interventions, medication history interview, drug information query and dispensing medicines etc.

#### 5. Evidence of Success:

The institution's efforts have resulted in a remarkable output in educating the students for improving the health care system by training the pharmacist activities and also received letter of appreciation from PvPI, KMC, and Warangal.

5. To facilitate the distribution and exchange of information and ideas amongst the students.
6. To initiate, implement, and obtain projects and activities that will help the institution.
7. To monitor the students from the training to accomplishment of the course and drive them in their area of interest accordingly to fulfil their Professional dreams and get placed in their interested area after stepping out from this institute.

### 1. Context

The importance of curriculum topics, systematic planning and effective teaching developed interest of students in the subject which improved overall attendance of students and enhanced learning process in them. The teaching lesson plan of the subject by the teacher makes delivery of syllabus easy and provides idea to the teacher for effective teaching.

The formation of **Student activity cell** increased the involvement of students in the affairs of the institution, in cooperation with the teachers.

### 1. The Practice

The monitoring system at every level includes like the efficient implementation of academic planning, coordination of co-curricular and extracurricular activities, coverage of the syllabus, student attendance and academic progress, etc. A teacher is assigned as a faculty advisor who coordinates with the students to arrange various activities. It has demonstrated a significant improvement in students' self-discipline, regularity, punctuality and sincerity about their studies when paired with other activities to shape their whole personalities. The rapport between students and teachers has improved and students now feel comfortable approaching teachers with their difficulties. The results showed that student involvement in co-curricular and extracurricular activities was on the rise.

### 6) Problems encountered and resources required

A few students who came from nearby villages were unable to reach the college on time due to the delays in public transport system, at times.

A few students did not find themselves comfortable to come forward and talk about their problems. The teachers talked to them in convincing manner and made them feel at home.

Counseling of the students on a regular basis is required to make them feel free to communicate and participate in the activities of their choice.
